

The 2022-2023 Budget Provides Funds for:

\$82,250 <u>Technology</u>: Google Enterprise; smartboard software renewal; software for employee related forms; umbrella network protection; FM System, replace existing access points, and other contingencies for repairs/replace technology.

\$187,000 Security: 4 Class III officers, extended school year security, after school security guard.

\$560,442 Personnel: 1-Elementary Teacher(RV 5th); 1 Speech Therapist; increase staff FTEs as needed; 2- FT professional aides; 1.5 transportation personnel; increase in substitute salary; continue summer program; increase in nurses all schools; increase in health benefits for new staff.

\$231,340 Mental Health & Other: Continue with St. Clare's Clinical Service Program and the Uncommon Thread Behavioral Health Program.

S266,000 Curriculum & Other: Online books; library books; replacement of workbooks; woodwork supplies; gifted and talented expo; replacement of classroom books and materials; consultant communication, strategic plan; increase in free lunch program, & other misc. curriculum expenditures.

\$1,847,650 Facilities and Transportation: LV Electrical Upgrade; Repointing & Concrete work-District-wide; VV-Cafeteria, Band, & Art room HVAC replacement; VV-Repave parking lot; Repair interior doors; outsource three transportation routes; and other miscellaneous projects district-wide.

- The budget accounts for a 0.75% increase in tax levy
- This budget reflects an increase in State Aid in the amount of \$464K.
- A new five-year strategic plan will be created during the 22/23 School Year.
- The administration continues working to bring in new revenue- Rentals, Tuition, Grants, etc.
- The District is Debt Free and continues improving the facilities utilizing capital and maintenance reserve.

Reminder- this budget represents the tax impact only for Denville PK-8 BOE- Town, County and MHRD budgets are separate
